

Captain Jack 4 Hire Booking Policy/Contract

A 50% deposit is required to reserve a time slot for an appearance.
Balances must be paid in full within 7 days from the date of the deposit to guarantee a reservation.

Full payment is required no later than 7 days prior to an appearance to avoid forfeiture of deposit.

Expenses and or Additional Costs

Staying in true pirate character, Captain Jack Morgan does not carry US Dollar Bills, but will on occasion, be seen flashing a few golden coins to get what he needs.

Expenses such as, Parking, Valet Parking, Admission, Entrance Fees or Cover Charges required to make the appearance, must be prepaid or disclosed by the customer prior to booking, so that compensation or reimbursement can be addressed.

In the event of a Late Night, or a Multi Day Appearance, hotel accommodations near the event should also be discussed prior to booking.

Other Accommodations

Certain events require credentials to be worn at all times. In this case, we ask that his name appear as "Captain Jack" or "Special Guest" on the ID. Also that an All Access or VIP Pass be provided so that he is not required to come out of character dealing with gate or building security and that a second Pass be issued for his handler, if a handler is not provided by the event.

For outdoors or appearances greater than 2 hours, we ask that hydration or refreshments be provided, including a place for a brief retreat from the sun and or guests.

Cancellations

Cancellations made by Sigs of the West/Pirates of the Treasure Coast:

Are 100% refundable to the customer!

Cancellations made by customer:

If you elect to cancel an appearance, you are entitled to a 100% refund***
Provided the cancellation is 73 hours or more before the time of the appearance.

Cancellations made between 48-72 hours of the appearance will receive a 50% refund. ***

Cancellations made less than 48 hours of an appearance are non-refundable.

Cancellations due to weather are non-refundable:

If the customer reschedules the appearances date or time, and our Captain Jack is not available for the new time or date, regardless of reason, deposits and or payments will remain non-refundable.

*** Due to the strict policies of travel agencies, certain travel expenses including but not limited to, airfare, car rental, or hotel accommodations, may not be refundable.
